All warranty claims must be returned to Firefly for assessment.

Firefly has no liability to remedy any defect in a product or replace a product where the defect or fault is caused or contributed to by

*(1) the failure of the Purchaser to install the product according to specific installation instructions either supplied within each product box or carton or available on the Firefly website or through the wholesaler or Firefly's representative; or
(2) use of the product in a manner or for a purpose for which it was not designed.*

*(3) Water or moisture ingress to any of the products.
(4) Over-voltage or incorrect driver or transformer.*
